## TV CAREER CONSULTATION

- One-hour: **\$300**

## WRITING, SCRIPT AND BIBLE SERVICES

For writing, pitch, script and bible services, material reading time is not charged by the hour; notes prep and/or call/remote meeting time is re charged at the hourly rate. For flat rate services, reading, notes prep and call/remote meeting time is included in the package rate.

## TV WRITING CONSULTATION

### General Writing Services Consultation

- Hourly rate: **\$300** per hour

### Finding The Right Idea

- Up to one page of television show ideas, reviewed, with notes: **\$100**

### Logline

- Loglines review, for up to 5 loglines. With notes: **\$150**

### Treatment

- Margin notes (a mark-up of your document for structure and analysis, grammar, clarity, typos, improved copy and layout): **\$350**
- Margin notes plus up to four pages of detailed notes: **\$500**
- Margin notes plus up to four pages of detailed notes plus a thirty-minute call: **\$650**

### Beat Sheet & Outline

- Beat Sheet: Up to a 4-page beat sheet, analyzed, with notes and a half-hour call to discuss: **\$300**
- Half Hour Outline: Up to a 15-page outline, analyzed, with notes only: **\$400**
- Half Hour Outline (up to 15 pages) plus a one-hour call: **\$600**
- One-hour Script Outline: Up to a 25-page outline, analyzed, with notes only: **\$600**
- One-hour Script Outline (up to 25 pages) plus a one-hour call: **\$850**

## TV SCRIPT CONSULTATION

- Level Two: Script is read and analyzed; 3-4 pages of written notes are sent to you, and we'll have a one-hour consultation to discuss the notes in detail. You prepare a second draft and we repeat the process: **\$900**
- Level Three: Script is read and analyzed; 3-4 pages of written notes are sent to you, and we'll have a one-hour consultation to discuss the notes in detail. You prepare a second draft and we repeat the process. You prepare a third draft and we again repeat the process: **\$1,300**

### One-Hour Script Consultations (Scripts up to 60 pages)

- Level One: Script is read and analyzed; 5-6 pages of written notes are sent to you, and we'll have a one-hour consultation to discuss the notes in detail: **\$700**
- Level Two: Script is read and analyzed; 5-6 pages of written notes are sent to you, and we'll have a one-hour consultation to discuss the notes in detail. You prepare a second draft and we repeat the process: **\$1,100**
- Level Three: Script is read and analyzed; 5-6 pages of written notes are sent to you, and we'll have a one-hour consultation to discuss the notes in detail. You prepare a second draft and we repeat the process. You prepare a third draft and we again repeat the process: **\$1,500**
